

# **Microsoft's Matching Gift Program**

# **Matching Gift Information**

Microsoft matches up to \$15,000 at a 1:1 ratio. Full-time and part-time employees can submit requests for a match.

#### **Volunteer Grant Information**

Microsoft does not require a minimum amount of hours for employees to receive a volunteer grant on behalf of organizations. The company will offer \$25 per hour volunteered.

#### Microsoft's Matching Gift Submission Process

Employees / donors can submit their matching gift requests electronically at https://microsoft.benevity.org/. **Deadline** 

Donors can submit match requests for donations made at any point in the last 12 months.



# Apple's Matching Gift Program

# **Matching Gift Information**

Apple will match a maximum of \$10,000 at a ratio of 1:1 for full-time and part-time employees. **Volunteer Grant Information** 

Apple also offers volunteer grants, with no minimum required hours. Apple will donate \$25 for every hour an employee volunteers with an organization.

#### Apple's Matching Gift Submission Process

Employees of Apple can log into <u>https://apple.benevity.org/</u> to view complete guidelines. Additional information on organization eligibility can be found at <u>https://doublethedonation.com/forms/apple-guide.pdf</u>. **Deadline** 

Employees must submit their matching gift request within 1 month of the donation date.

# Google Google's Matching Gift Program

# Matching Gift Information

Google will match up to a maximum of \$10,000 at a 1:1 ratio for full-time and part-time employees.

# Volunteer Grant Information

Google also offers a volunteer grant program, offering \$10 for every hour that an employee volunteers, with a minimum of 1 hour required.

#### **Google's Matching Gift Submission Process**

Employees should search the company intranet for matching gifts while connected to the company intranet to locate the most up to date electronic submission link. Alternatively, Employees should submit their requests electronically at https://google.benevity.org/.

#### Deadline

Matching gift requests must be submitted by January 31st of the year following the date of the donation.



#### **Matching Gift Information**

Full-time and part-time employees are eligible for a donation match, though retired employees are not. Starbucks will match up to \$1,500 per employee at a 1:1 ratio.

#### Volunteer Grant Information

Employees must commit a minimum of 25 hours for a maximum of \$1,000 in volunteer grants to eligible organizations.

# Starbucks' Matching Gift Submission Process

Employees / donors should register their matching gift requests electronically at https://starbucks.benevity.org/. Employees should log in with their global username & password.

#### Deadline:

Starbucks employees have 90 days from the donation date to request a matching gift.



# **Boeing's Matching Gift Program**

### Matching Gift Information

Boeing offers employees a 1:1 match for personal donations while retirees receive a 0.5:1 match.

# **Volunteer Grants Information**

Boeing offers volunteer grants to recognize employees who volunteer with nonprofit organizations. The company provides a \$250 grant for every 25 hours of volunteering (max \$6,000)

# Verizon's Matching Gift Program

# **Matching Gift Information**

Verizon will match up to \$5,000 for schools, or \$1,000 for other 501(c)(3) organizations, at a 1:1 ratio. The company also offers a Team Champions program, where teams of 10 or more employees can collectively raise funds for a nonprofit or school, and Verizon will match up to \$10,000 per team and event.

#### **Volunteer Grant Information**

Verizon offers volunteer grants of \$750 for an employee who volunteers 50 hours with that organization. Each employee can request up to two separate grants per year.

# **Submission Process**

Employees / donors should register their matching gift requests electronically by logging in

# Salesforce's Matching Gift Program

# **Matching Gift Information**

Full-time and part-time employees are eligible for a donation match to most nonprofits, with a maximum of \$5,000 per employee at a 1:1 ratio, and a minimum of \$50. Retired employees are not eligible.

#### **Volunteer Grant Information**

Salesforce employees who volunteer at least 56 hours within one fiscal year are eligible to receive a volunteer grant for the organization they volunteered with.

#### Salesforce.com's Matching Gift Submission Process

While connected to the company intranet, current employees can log in to Volunteer force via the Aloha homepage for the full Employee-Inspired Giving policy and to request matching gifts. Alternatively, employees may be able to submit their requests electronically at https://powerofus.force.com/vfx/s/.

#### **Matching Gift Information**

All full-time and part-time employees are eligible to request a gift match, though retired employees are not. HP matches a maximum of \$2,500 at a 1:1 ratio. Eligible nonprofits include educational institutions, arts and cultural organizations, and more.

#### Volunteer Grant Information

HP allows employees who volunteer on a regular basis to donate \$50 to a nonprofit of their choice each quarter. HP's Matching Gift Submission Process

Employees should log in at <u>https://hp.benevity.org/</u> to request a matching gift electronically.



# **Matching Gift Information**

Full-time and part-time employees are eligible to submit a match request, while retirees are not. The maximum match amount is \$10,000 at a 1:1 ratio, with a minimum of \$10. Dell will match employee donations to most eligible nonprofits.

#### **Volunteer Grant Information**

For each quarter a Dell employee volunteers more than 10 hours, they can allocate a \$150 donation toward a nonprofit organization.

# **Dell's Matching Gift Submission Process**

# **ORACLE's Matching Gift Program**

# **Matching Gift Information**

Full-time and part-time employees are eligible to submit a match request, while retirees are not. The maximum match

amount is \$1,000 at a 1:1 ratio, with a minimum of \$25. Oracle will match employee donations to most eligible nonprofits.

# Volunteer Grant Information

Oracle does not have a volunteer grant program.

# SAP's Matching Gift Program

# **Matching Gift Information**

All full-time employees are eligible to request a gift match, though retired and part-time employees are not. SAP matches a maximum of \$750.00 at a 1:1 ratio, with a minimum of \$50.00. Eligible nonprofits include educational institutions, arts and cultural organizations, and more.

# Volunteer Grant Information

SAP allows employees who volunteer on a regular basis to donate \$20 per hour to a nonprofit of their choice. **SAP's Matching Gift Submission Process:** 

SAP employees should submit matching gifts electronically at https://sapglobal.benevity.org.

Deadline

Donation must be registered by December 31<sup>st</sup> in order to be matched.



# Matching Gift Information

The Coca-Cola Company matches donations up to \$10,000 per year at **a 2:1ration.** If you donate \$100, Coke will write a check to the organization for \$200.

The Coca-Cola Company does not offer a volunteer grant program.
